Reasons for the Variance:

Similar to Quarter 1/2026, the operating results for Quarter 2/2026 compared with the same period of the previous year experienced significant changes in both revenue and profit, which were also affected by the impact of various subjective internal factors and objective external factors, specifically:

* Revenue for this quarter increased compared with the same period of the previous year, mainly due to the general education business officially commencing operations at the beginning of the 2025–2026 academic year (from August 2025 to the present) in accordance with the restructuring policy approved by the Board of Directors.

* Similar to the immediately preceding quarter, income from financial investment activities in Quarter 2/2026 decreased significantly compared with the same period of the previous year due to the impact of the ongoing energy crisis, which continues to spread globally and adversely affect the economies of most countries, including Vietnam. The Company's investment partners temporarily focused their resources on stabilizing their business operations during the first months of 2026. Accordingly, dividend income for this period declined significantly compared with the same period of the previous year, and therefore the Company's overall business performance for this quarter remained profitable but at a relatively low level.
